TUITION POLICIES 2012-2013



Tuition Rates

The tuition for 2012-2013 has been set by the GCS Board of Directors:
Grades K-4 tuition is \$11,398, Grades 5-8 tuition is \$12,895.

Deposit

Returning families must make a non-refundable deposit of \$1200 (or contracted) by March 12, 2012 to reserve a place for their child(ren). New families must make a non-refundable \$1200 deposit within two weeks of acceptance.

Application for Financial Aid

Deadlines for submission of Application for Financial Aid:

- 1) Returning families –February 10, 2012. Review and Financial Aid awards decided Feb. 10-14th, 2012.
- 2) New families – during the admissions application process.

Procedure:

- 1) Obtain Financial Aid form from the office or download from website.
- 2) Fill out and return the Application for Financial Aid.
- 3) Send a copy of 2011 Federal Income Tax Form 1040 or 1040A with all schedules and W-2 Forms attached. (Estimated due w/ FA App., Final due by March 4th, 2012. NECESSARY TO MAINTAIN AWARD.)

Financial Aid Eligibility:

Financial aid eligibility for the 2012-2013 school year will be determined using information provided on the Application for Financial Aid, the 2011 Federal Income Tax Returns and 2011 W-2 Forms. Parents requesting financial aid must provide complete information from the households of both parents.

Financial Aid awards are based upon need, timeliness of application and the limitations of GCS Budget. Please return forms in a timely manner!

Tuition Contract – Payment Options

Tuition Contract – All returning families must return a signed tuition contract by March 12, 2012, stating choice of payment option. New families must return signed contract within two weeks of receipt.

___3 payment option – No billing charge. Net tuition less deposit, payable in three (3) equal amounts on July 1, September 1 and December 1, 2012. A \$50.00 Billing Charges and finance charges will be assessed if any of these payments are late.

___9 payment option - \$50.00 annual billing charge in June. Net tuition less deposit, payable in 9 equal monthly installments starting June 1, 2012 and extending through February 1, 2013. Finance charges will be applied if payments are late.

Payment Terms

A Tuition Invoice List for 12-13 payments will be sent to parents upon receipt of the signed contract. Parents with balances are sent monthly statements the first week of each month based upon their choice of payment option. Payments are due by the last day of the month. **Balances not paid by the due date are subject to a 1.2% per month (14.4% annual) finance charge.**

Please note: Tuition needs to be current in order to reserve a place for your child.
